RECREATION CENTER RULES AND REGULATIONS

1. ID cards are required for entrance, except for program attendance and spectators at sanctioned sports games.
2. Each patron must purchase and scan their own ID card.
3. Fights and verbal threats will result in suspensions for everyone involved.
4. Alcohol and illegal drugs are not allowed.
5. Gambling, profanity, littering, and spitting are not allowed.
6. Admission to the facility will be refused to patrons with open wounds or contagious diseases.
7. Food and drinks are not allowed in the gym.
8. Shirts and shoes are required inside building.
9. Non-marking athletic shoes must be worn when playing in the gym. Tap shoes may only be worn during activity. No shoes with cleats are allowed inside building.
10. See-through clothing, swim suits, or exposed undergarments must be covered.
11. Clothing that is gang related or displays drugs, profanity, or pornography will not be permitted.

12. Only service animals of patrons with disabilities will be allowed inside the building.
13. Children 6 and under must be directly supervised by an adult at all times. Children 12 and under must be directly supervised by an adult 21 years or older after 6:00 PM.
14. Gym rentals are required for team practices.
15. All injuries must be reported to center staff immediately.
16. Do not use equipment that is not functioning properly. Please report damaged or malfunctioning equipment immediately.

Violation of these rules may result in suspension from Garland recreation centers.

IDENTIFICATION CARD STATEMENT

1. This card allows the person identified entrance to and use of City of Garland recreation facilities.
2. Youth ID cards are for ages 7 – 12 and Adult ID cards are for ages 13 and up.
3. A replacement fee of \$3 will be charged for lost or damaged cards.
4. The Garland Parks and Recreation Department reserves the right to check personal identification.
5. This card is the property of the Garland Parks and Recreation Department and must be returned upon request by Department personnel.
6. The use of this card is governed by, and the cardholder agrees to abide with, the policies and procedures of the City of Garland Parks and Recreation Department.
7. This card is non-transferable and will expire one year from date card is issued.

Indemnification Agreement

In return for use of facilities, the Patron agrees to indemnify, hold harmless and defend the City of Garland, its officers, agents, and employees, both past and present, from and against liability for any and all claims, liens, suits, demands, and actions for damages, injuries to persons (including death), property damage (including loss of use), and expenses (including court costs, attorneys' fees and other reasonable costs of litigation) arising out of or resulting from any liability arising out of or resulting from intentional acts or negligence of the City, including all such causes of action based upon common, constitutional, or statutory law, or based in whole or in part upon the negligent or intentional acts or omissions of the Patron, including but not limited to its officers, agents, employees, subcontractors, licensees, invitees, and other persons. It is the express intention of the parties hereto, both the City and the Patron, that the indemnity provided for in this Agreement indemnifies and protects the City from the consequences of the City's own negligence. Furthermore, I authorize any emergency medical or dental treatment should it become necessary.

I understand the above rules, regulations, and indemnification agreement and agree to abide by them.
